1. Welcome and objectives for the meeting

3. Minutes of last meeting

This was the first committee meeting and so there were no minutes to review.

4. Presentations

The Chair introduced Shona Burman-Roy, Senior Research Fellow and Interim Guideline Lead, who gave presentations on guideline development, conflicts of interest, developing a review protocol, reviewing the evidence and linking evidence to recommendations. After these presentations Shona took questions from the Committee.

Shona also gave a presentation on the interface between this guideline and the NICE guideline on intrapartum care for healthy women and babies (CG190). The Committee discussed the issues presented in relation to this guideline. The Chair thanked Shona for her presentations.

The Chair gave presentations on the role and responsibilities of Committee members and the guideline scope. After the presentation the Chair took questions from the Committee.

The Chair introduced Clifford Middleton, Guidelines Commissioning Manager, who gave a presentation on how NICE guidelines are developed. After the presentation Clifford took questions from the Committee.

The Chair introduced Simran Chawla, Public Involvement Adviser who gave a presentation on how NICE guidelines are developed. After the presentation Simran took questions from the Committee.

The Chair introduced Tim Reeves, Information Scientist, who gave a presentation on information science in guideline development. After the presentation Tim took questions from the Committee.

The Chair introduced Paul Jacklin, Senior Heath Economist, who gave a

presentation on health economics in guideline development. After the presentation Paul took guestions from the Committee.

The Chair introduced Gary Waltham, Senior Director, who gave a presentation on the National Guideline Alliance (NGA).

In June 2015, the RCOG was awarded a 6-year contract by NICE to bring together the work of the preceding National Collaborating Centres (NCCs): the NCC for Women's and Children's Health (NCC-WCH) already hosted by the RCOG, the NCC for Cancer (NCC-C), previously based at the Velindre NHS Trust, Cardiff; and the NICE component of the NCC for Mental Health (NCC-MH), previously based at the Royal College of Psychiatrists to create a single, multidisciplinary centre.

Developing 15 guidelines at any one time, the NGA was due to launch on 1st April 2016. All NICE guidelines in development in the three former NCCs would transfer to the responsibility of the NGA. Committee members should expect minimal changes with continuity of both processes and staff supporting each guideline to be maintained in most instances.

After the presentation Gary took questions from the Committee.

The Committee thanked Shona, Clifford, Simran, Tim, Paul and Gary for their presentations and contribution to the development of the guideline.

5. Questions and discussion

The Committee discussed and finalised the review protocol for mode of birth for women with sepsis.
