1. Welcome and objectives for the meeting

In the Chair's absence, MMa welcomed the Committee and technical team to the tenth meeting for Intrapartum Care for High-Risk Women – Obstetric Complications.

MMa informed the Committee that apologies had been received as noted above.

MMa outlined the objectives of the meeting, which included the following:

- finalising review protocols for questions on management for women with sepsis in the first 24 hours after birth, the use of anti-pyretics and fetal blood sampling in women with pyrexia, and the information needs of women at high risk of adverse outcomes in labour due to obstetric complications
- discussion of the evidence and drafting recommendations for analgesia for women with sepsis and fetal monitoring for women with sepsis.

2. Confirmation of matter under discussion, and declarations of interest

MMa confirmed that for the purpose of managing conflicts of interest the matter under discussion was intrapartum care for women at high risk of adverse outcomes because of obstetric complications. The Chair asked everyone to verbally declare any interests that had arisen since the last meeting and to remind the Committee of any interests declared previously that had a bearing on the matters to be discussed at the meeting.

MMa and a senior member of the Developer's team noted that the interests declared did not prevent the attendees from participating fully in the meeting.

3. Minutes of last meeting

MMa asked the Committee if it wanted any changes made to the minutes of the last meeting. The Committee agreed that the draft minutes were a true and accurate account of the meeting.

4. Presentations

MMa introduced LKu to the Committee who presented the review protocols for "What is the optimal mode of birth (emergency caesarean section or continuation of labour) for women with breech presenting in the first or second stage of labour?" and "What maternal and fetal monitoring should be carried out for women in labour after 42 weeks of pregnancy?". LKu also presented the evidence for anaesthesia for women with sepsis in labour and fetal monitoring for women with sepsis in labour. LKu took questions from the Committee.

The Chair introduced RC to the Committee who presented the review protocols for "What is the optimal mode of birth (emergency caesarean section or continuation of labour) for women with a large for gestational age baby?", "What are the most appropriate systems for risk assessment and management of labour for women who present in labour having had no antenatal care?", "What maternal and fetal monitoring should be carried out for women in labour after 42 weeks of pregnancy?", "How should the first and second stages of labour be managed for women with previous caesarean section?" and "How should fetal monitoring be managed during labour for women with a small-for-gestational age baby?". RC took questions from the Committee.

5. Questions and discussion

The Committee discussed and finalised the review protocols for management for women with sepsis in the first 24 hours after birth, the use of anti-pyretics and fetal blood sampling in women with pyrexia, and the information needs of women at high risk of adverse outcomes in labour due to obstetric complications.

The Committee discussed the evidence for anaesthesia for women with sepsis in labour and made recommendations based on this.

The Committee discussed the evidence for fetal monitoring for women with sepsis in labour and decided to defer making recommendations until they had head the evidence for fetal blood sampling and women with pyrexia.

The Committee discussed queries in the evidence report for analgesia for women

with sepsis.
