1. Welcome and objectives for the meeting

The Chair welcomed the Committee and technical team to the twelfth meeting for

Intrapartum Care for High-Risk Women – Obstetric Complications.

The Committee discussed the evidence for fetal blood sampling in women with pyrexia. The Committee discussed the possible inclusion of additional evidence for this and some other review questions, identifying priority areas where this would be most informative.

The Committee discussed difficulties surrounding the definition of sepsis for women in labour.
