1. Welcome and objectives for the meeting

The Chair welcomed the Committee members, co-opted members and technical team to the third meeting for Intrapartum Care for High-Risk Women – Obstetric Complications.

The Chair informed the Committee that apologies had been received as noted above.

The Chair outlined the objectives of the meeting, which included the following.

- Complete discussion of evidence included in CG190
- Discuss evidence published after CG190
- Complete review of 2014 recommendations
- Agree amendments to evidence to recommendations sections

2. Confirmation of matter under discussion, and declarations of interest

The Chair confirmed that for the purpose of managing conflicts of interest the matter under discussion was intrapartum fetal monitoring.

The Chair asked everyone to verbally declare any interests and these were confirmed in writing.

3. Minutes of last meeting

The Chair asked the Committee if it wanted any changes made to the minutes of the last meeting. The Committee agreed that the minutes were a true and accurate account of the meeting. The NGA sought clarification on some of the interests declared at Committee meeting 2 and this was provided. The minutes were revised accordingly. It was also agreed that the date of the next meeting at the end of the minutes would be revised for accuracy.

4. Presentations

The Chair introduced May Oo Khin who presented the new evidence found for "Does the use of fetal blood sampling as an adjunct to electronic fetal monitoring improve outcomes, when compared to: electronic fetal monitoring alone; electronic fetal monitoring plus electrocardiogram?" and "What is the predictive value of the following measures, for maternal and neonatal outcomes: fetal blood pH analysis; fetal blood lactate analysis; fetal acid-base status; fetal base deficit?" May took questions from the group.

The Chair introduced Laura Kuznetsov who presented the new evidence found for "What is the optimum time from the decision to perform a fetal blood sample to having the blood result?" and "Does automated interpretation of cardiotocograph traces using computer software improve consistency of interpretation and outcomes (neonatal and maternal)?" Laura took questions from the group.

Laura and May presented the new evidence found for "Does the use of fetal stimulation as an adjunct to electronic fetal monitoring improve the predictive value of monitoring and clinical outcomes when compared with: electronic fetal monitoring alone; electronic fetal monitoring plus electrocardiogram?" They took questions from the group.

The Chair introduced Paul Jacklin who presented the CG190 evidence on health economics for "What is the predictive value of the following measures, for maternal and neonatal outcomes: fetal blood pH analysis; fetal blood lactate analysis; fetal acid-base status; fetal base deficit?" Paul took questions from the group.

The Chair introduced Lyn Knott who presented information on drafting recommendations. Lyn took questions from the group.

The Chair introduced Maryam Parisaei who presented anonymised examples of cardiotocograph (CTG) traces to the group. The Committee then discussed practicalities involved in interpretation of CTG traces.

The Chair introduced Maija Kallioinen and Rami Cosulich who presented new evidence for "What are the appropriate definitions and interpretation of the features of an electronic fetal heart rate trace?" Maija and Rami took questions from the group.

5. Questions and discussion

The Committee discussed new evidence that had been presented and began to review and update the CG190 recommendations. Notes were taken to guide updating of the corresponding evidence to recommendations sections.

6. Any other business

There was no other business. The Chair reminded the Committee of the date of the next meeting and closed the meeting.
