The Chair introduced Shona Burman-Roy, NGA Senior Systematic Reviewer, who gave a presentation on Protocol: What is the most appropriate method of diagnosis for women with suspected cardiomyopathy in labour?

The Chair introduced Shona Burman-Roy, NGA Senior Systematic Reviewer, who gave a presentation on Protocol: What is the optimal management for women with peripartum cardiomyopathy in labour?

The Chair introduced Alex Bates, NGA Guideline Lead, who gave a presentation on Protocol: Which women with cardiac disease should be offered elective caesarean

section or assisted second stage for reasons specific to cardiac disease?
