The Chair introduced May Oo Khin, NGA Systematic Reviewer, who gave a summary presentation of the evidence and drafted recommendations on:

- 20. What is the most effective fluid management regimen for women who develop an acute kidney injury or have chronic kidney disease and who are in the peripartum period?
- 21. Which women who develop an acute kidney injury or have chronic kidney disease should be offered elective caesarean section for reasons specific to kidney disease?

The Chair introduced Maija Kallioinen, NGA Systematic Reviewer, who gave a presentation on: Evidence review: 2. Does antenatal planning for birth involving an expanded multidisciplinary team compared with routine antenatal care planning improve intrapartum outcomes for women with existing medical conditions?

The Chair introduced Paul Jacklin, NGA Senior Health Economist, who gave a presentation on: Health economic Evidence review: 2. Does antenatal planning for birth involving an expanded multidisciplinary team compared with routine antenatal care planning improve intrapartum outcomes for women with existing medical conditions?

The Chair introduced Alex Bates, NGA Guideline lead, who led a discussion on drafting research recommendations.

The Committee discussed the issues presented in relation to this guideline.

The Committee thanked the speakers for their presentations and contribution to the development of the guideline.
