1. Welcome and objectives for the meeting

The Chair, Sarah Fishburn, welcomed the committee and attendees to the 2nd meeting on multiple obstetric guidelines update.

The Chair informed the committee that apologies had been received. These are noted above.

2. Confirmation of matter under discussion, and declarations of interest

The Chair confirmed that, for the purpose of managing conflicts of interest, the matter under discussion were multiple obstetric topics on hypertension in pregnancy, ectopic pregnancy, caesarean section, induction of labour and preterm labour and birth.

4. Morning presentations and discussions

Katie Webster presented protocols for the following review questions:

- HiPQ7 How effective are spot protein/creatinine ratio or albumin/creatinine ratio measurements as compared with a 24 hour urine collection for the identification of proteinuria in women with hypertensive disorders in pregnancy?
- EPQ1 What ultrasound features are most diagnostic of a tubal ectopic pregnancy?

• EPQ2 – How effective is expectant management compared to medical management for ectopic pregnancy?

Eva Gonzalez-Viana presented the evidence review for question HiPQ1 – What interventions for chronic hypertension are effective at improving outcomes for women and infants?

5. Afternoon presentations and discussions

The Chair introduced Gareth Murphy, NICE Business Analyst, who gave a presentation on NICE resource impact assessment.

Lucy Chappell presented the revised definition of pre-eclampsia and its impact on the hypertension in pregnancy guideline update.

Eva Gonzalez-Viana presented the evidence review for question HiPQ4 – What interventions are effective at improving outcomes for women and infants in women with pre-eclampsia?

6. Questions and discussions

The protocols for HiPQ7, EPQ1 and EPQ2 were signed off by the committee.

The committee discussed the evidence presented for HiPQ1 and made recommendations.

The committee discussed the paper presented on the revised definition of preeclampsia and agreed to Lucy Chappell's recommendations.

The committee discussed the evidence presented for HiPQ4 and made recommendations.

The discussion on the NICE editor's recommendations made at the previous meeting (HiP5 – what is the optimal management of hypertension for women in the post-natal period?) was deferred until the next meeting.
