- 4.2. Introductory Presentation: Thyroid function tests. KB, the Committee Topic Advisor for this guideline, delivered a presentation on Thyroid Function Tests to assist the group with interpreting the evidence for the review that would be presented in this meeting.
- 4.3. The evidence review on Thyroid Function Tests was presented to the committee by JG. The group discussed the clinical and economic evidence and drafted recommendations for this area.
- 4.4. The evidence review on Fine-needle aspiration biopsy was presented to the committee by JG. The group discussed the clinical and economic evidence and drafted recommendations for this area.
- 4.5. Review protocols: JG led the committee's discussions on the development of review protocols for the guideline for the topics:
 - 4.5.1. Monitoring non-malignant thyroid enlargement
 - 4.5.2. Monitoring hypothyroidism
 - 4.5.3. Monitoring thyrotoxicosis.
 - 4.5.4. Imaging tests and who should have Fine needle aspiration biopsy.
