### 1. Welcome and objectives for the meeting

#### 2. Agree questions for rerun searches

#### 3. Reminder of topic group allocations

The Chair introduced ZA, NGA Project Manager, who presented the upcoming schedule of topic group allocations and milestones to the committee.

4. Review question 9: What is the effectiveness, cost-effectiveness, and acceptability of interventions for supporting adult carers during: (i) changes to the setting in which caring is performed; (ii) the transition of the person receiving care to adulthood; and (iii) change of carer status or circumstances?

The Chair introduced AM, NGA Systematic Reviewer, who presented an overview of recommendations from existing published NICE guidelines that were relevant to

review question 9 to assist committee discussions.

FP, NGA Systematic Reviewer, presented an overview of the quantitative, qualitative and cost-effectiveness evidence for review question 9 to the committee.

The committee were given the opportunity to ask questions.

The Chair introduced committee member JFa, who presented feedback on the evidence review for question 9 on behalf of the topic group.

The Chair led a discussion of the evidence with the committee, and the committee drafted recommendations based on review question 9.

# 5. Review of draft recommendations and committee discussion of evidence for RQ4 – work, education and training

JFr, NGA Senior Systematic Reviewer, presented the latest draft version of the recommendations and committee discussion of evidence for RQ4 to the committee for review.

The committee reviewed the relevant sections and suggested some edits.
