#### 1. Welcome, housekeeping, aims of the day and apologies

The Chair welcomed the committee members to the 6th committee meeting for the colorectal cancer guideline (update).

The Chair informed the committee that apologies had been received as noted above.

The Chair outlined the objectives of the meeting, which included:

- Presentation of evidence for **review questions 5.2** (What is the optimal management of low anterior resection syndrome?);
- Economic modelling review for **review question 3.6** (What is the optimal surgical technique for rectal cancer?);
- Presentation of evidence for review question 5.1 (What are the optimal methods and frequencies of follow-up after potentially curative surgical treatment for colorectal cancer (primary or metastatic)?);
- Presentation of evidence for **review question 5.3** (What are the information needs of people prior, during and after treatment for colorectal cancer?);

The minutes of the 5th colorectal cancer guideline committee meeting were confirmed with the Committee.

The Chair led round the table introductions for the group. The Chair confirmed that, for the purpose of managing conflicts of interest, the matter under discussion was colorectal cancer.

#### 2. Review 5.2 What is the optimal management of low anterior resection syndrome?

The Chair introduced Maija Kallionen (NGA Systematic Reviewer) who presented the evidence review for question 5.2 and the conclusions from the clinical evidence and took questions from the committee. The Chair then drafted the recommendations with the committee.

# 3. Review 5.1 What are the optimal methods and frequencies of follow-up after potentially curative surgical treatement for colorectal cancer (primary and metastatic)?

The Chair introduced Nathan Bromham (NGA Senior Systematic Reviewer) who presented the evidence review for question 5.1 and the conclusions from the clinical evidence and took questions from the committee. The Chair then drafted the recommendations with the committee.

## 4. Economic modelling review 3.6 What is the optimal surgical technique for rectal cancer?

The Chair introduced Matthew Prettyjohns (NGA Senior Health Economist) who presented the draft of the economic model for review question 3.6 and took questions from the committee.

## 5. Review 5.3 What are the information needs of people prior, during and after treatment for colorectal cancer?

The Chair introduced Audrey Tan (NGA Systematic Reviewer) who presented the evidence review for question 5.3 and the conclusions from the qualitative evidence and took questions from the committee. The Chair then drafted the recommendations with the committee.
