3. Minutes of last meeting

The minutes of the last meeting were agreed as a true and accurate record of the meeting.



4. Presentations

Katharina Dworzynski, NGA Guideline Lead, gave a presentation on: Introduction to Minimally Important Differences (MIDs), Cochrane Systematic Reviews, and Drafting Recommendations, Impact and Rationale.

Sadia Janjua, NGA Systematic Reviewer, presented the clinical evidence report for review question 3.10.

Sadia Janjua presented protocols for review questions 1.1 and 3.12.

Katharina Dworzynski presented protocols for review questions 1.2 and 2.1.

Alex Bates, NGA Senior Health Economist, presented the Health Economic plan for the guideline.

5. Questions and discussions

Katharina and Sadia led the Committee in finalising the remaining draft guideline review questions.

The clinical evidence presented for question 3.10 was insufficient to suggest that iron supplement should be routinely administered to preterm or term babies who are receiving parenteral nutrition within the first 3 weeks of life. There was no evidence of benefit or harm.

Additionally, the need for blood transfusions was felt to be unrelated to iron status in the neonatal period. There is no physiologically basis or reason to provide extra iron until 4-6 weeks of life, which is outside the scope of this guideline.

The health economic model concepts were discussed with the Committee. As part of the health economic model/plan, the Committee has asked to include a cost-effective comparison between bespoke parenteral nutrition bags made by in-house pharmacists or manufacturers.

6. Any other business
