1. Welcome and objectives for the meeting

3. Minutes of last meeting

5. Questions and discussions

The role of the editorial lead

During the presentation on the role on the editorial lead, the GC pointed out that there needs to be clarity on the use of the word "offer", which usually implies that parents have the option to choose to apply or not apply the recommendation, especially in children's guidelines. Parents find they have to make the decision on behalf of the child, but there is no certainty that they are making the right decision. The language used to make recommendations has to reflect the right decision and must be finalised cautiously. The GC would also recommend that plans should always be discussed between the clinician and service user.

There was an ongoing discussion amongst the GC on the insufficiency of evidence to make a strong recommendation for administering IV iron to preterm and term babies in the first 3 weeks of life, which would therefore require clinical discretion in the wording being used to recommend. "Consider" would be a suitable term to use for a recommendation in this case and reflects the ambiguity of evidence, but in reality, this may be misinterpreted to mean a firm instruction that has to be followed.

In the absence of evidence, the GC agreed to make a "do not" recommendation for providing IV iron within the first 3 weeks of life (which is within the timeline of this guideline).

The Committee consensus approach was taken for making recommendations for administering IV carbohydrates, as the available evidence was not relevant to the protocol. Parenteral nutrition only started in the 1980s, so evidence before this time period would be misleading. It was also concluded that further studies potentially containing evidence relevant to the protocol would be reviewed.

6. Any other business

Actions and decisions log from the previous meeting was reviewed and a new one for today's meeting filled in.
