1. Welcome and objectives for the meeting

The Chair welcomed the committee members and attendees to the eighth meeting on Joint replacement (primary): hip, knee and shoulder. The Committee members and attendees introduced themselves.

The Chair outlined the objectives of the meeting, which included evidence reviews of intraoperative anaesthetic approaches in adults having elective hip joint replacement, evidence reviews of patella resurfacing vs no resurfacing vs selective resurfacing in adults having elective total knee replacement, an update of economic modelling prioritisation and reviewing of draft committee discussions including: Anaesthesia Hip, Total vs partial knee replacement, patella resurfacing, inpatient hip and knee rehab, inpatient shoulder rehab, outpatient hip and knee rehab.

The committee discussed and asked questions about the evidence and drafted recommendations.
- B. Rafina Yarde, Research Fellow at the NGC, presented the updated clinical evidence and RK presented the updated health economic evidence for the review question 7.2, 'In adults having elective knee replacement, what is the clinical and cost effectiveness of total knee replacement with patella resurfacing versus total knee replacement without patella resurfacing versus total knee replacement with selective resurfacing?' The committee discussed and asked questions about the evidence and drafted recommendations.
