1. **Welcome**

The Chair welcomed the group to the eighth guideline development group meeting.

2. **Minutes of previous meeting**

The minutes and actions from GDG7 were reviewed. The minutes were accepted as a true and accurate record of the meeting.

3. **Declarations of interest**

The chair asked the group if there were any new interests to declare. Arthur Durrant declared membership of the lay advisory panel at Sheffield Teaching Hospitals NHS Foundation Trust. This does not constitute a conflict and no action is necessary.

4. **Linking evidence to recommendations (LETs) from GDG7**

LETs from GDG7 (on short acting insulin and mixed insulin) were circulated to GDG members with the meeting papers. .

5. **Update on pancreas questions**

Since the last GDG meeting, we have clarity from NICE that we are being asked to cover pancreas transplant, and islet cell transplantation. The GDG discussed and agreed the clinical question.

6. **Evidence review: timing, frequency and targets for self-monitoring blood glucose (SMBG)**

Clinical and cost effectiveness evidence was presented and discussed by the GDG. Draft recommendations were made.

7. **Revisit aspirin**

The evidence for aspirin was originally reviewed at GDG2. Additional data has since been included in the evidence report, and so it was re-presented to the GDG. The new data did not change the recommendation drafted at GDG2 (only minor editorial changes were made).

8. **Protocols**

The GDG finalised the protocols for the following clinical questions:

- Gastroparesis
- Inpatient i.v. insulin
