### 1. Welcome and objectives for the meeting

**Item 3:** Alec Martin, Systematic Reviewer, presented Evidence Review for RQ 1.2: What co-existing medical, social (including family, cultural and ethnicity), and communication, neurodevelopmental, cognitive or mental health problems pose barriers for people with complex psychosis and related severe mental health conditions in accessing rehabilitation services?

Anuja presented the clinical evidence found. The committee discussed this evidence.

**Item 4:** Anuja Pandey, Systematic Reviewer, presented Evidence Review for RQ 3.1: What principles should guide adjustments to standard treatments in the management of the underlying psychosis in people using rehabilitation services?
