- Q3.3 'What approaches are effective in responding to neglect in care homes?'
- Q3.4 'What is the acceptability of approaches to managing and responding to safeguarding concerns for practitioners, people in care homes, and families and carers?'

The Chair introduced Anastasios Bastounis, NGA Systematic Reviewer, who gave a presentation on the draft Protocols for:

Q6.1 'What is the effectiveness of different models of training for safeguarding in



care homes?'

Q7.2 'What is the effectiveness and acceptability of approaches to embed learning in organisations about safeguarding in care homes in order to prevent neglect?'
