### **1. Welcome, objectives for the meeting**

The Chair welcomed the Committee members and attendees to the 6<sup>th</sup> guideline committee meeting on Rehabilitation after traumatic injury. The Committee members and attendees introduced themselves.

The Chair reminded all present that the Committee is independent and advisory, that its decisions and recommendations to NICE do not represent final NICE guidance, and that they may be changed as a result of public consultation.

The Chair informed the Committee that apologies had been received which are noted above.

### **1. Confirmation of matter under discussion, and declarations of interest**

The Chair confirmed that, for the purpose of managing conflicts of interest, the matter under discussion was Rehabilitation after traumatic injury. The Chair asked everyone to verbally declare any interests.

The Chair and Guideline Lead noted that the interests declared in the registry did not prevent the attendees from fully participating in the meeting.

### **1. Minutes of the last meeting**

The Chair asked the committee to confirm the minutes of the last meeting. The committee attendance list was corrected and the committee confirmed that no further changes were required.

### **4. Morning presentations**

The Chair introduced Gareth Murphy, NICE Business Analyst who presented about Resource Impact Assessment.

The Chair introduced Mia Schmidt-Hansen, Senior Systematic Reviewer, who presented draft protocols for discussion, amendment and agreement by the committee:

1.1a – What should be included in rehabilitation needs identification and assessment for adults after traumatic injury?

1.1b - What should be included in rehabilitation needs identification and assessment for children and young people after traumatic injury?

1.2a - What are the views and preferences of adults who have used rehabilitation services after traumatic injury about ongoing assessment of their rehabilitation needs?

1.2b - What are the views and preferences of children, young people, their families and carers who have used rehabilitation services after traumatic injury about ongoing assessment of their rehabilitation needs?

## **5. Afternoon presentations**

Mia Schmidt-Hansen continued the presentation on protocols

4.1a - What are the best methods to coordinate rehabilitation services within major trauma centres or trauma units for adults with complex rehabilitation needs after traumatic injury?

4.1b - What are the best methods to coordinate rehabilitation services within major trauma centres or trauma units for children and young people with complex rehabilitation needs after traumatic injury?

4.2a - What are the best methods to deliver and coordinate rehabilitation services and social care services for adults with complex rehabilitation needs after traumatic injury when they transfer from inpatient to outpatient rehabilitation services?

4.2b - What are the best methods to deliver and coordinate rehabilitation services and social care services for children and young people with complex rehabilitation needs after traumatic injury when they transfer from inpatient to outpatient rehabilitation services?

The committee also considered the issues of follow-up for people with complex rehabilitation needs.

4.3a - What are the barriers and facilitators to accessing rehabilitation services following discharge to the community for adults with complex rehabilitation needs after traumatic injury?

4.3b - What are the barriers and facilitators to accessing rehabilitation services following discharge to the community for children and young people with complex rehabilitation needs after traumatic injury?

4.4a – What are the support needs and preferences of adults who have complex rehabilitation needs after traumatic injury when they transfer from inpatient to outpatient rehabilitation services?

4.4b - What are the support needs and preferences of children and young people who have complex rehabilitation needs after traumatic injury, and their families and carers, when they transfer from inpatient to outpatient rehabilitation services?
