Rebecca Harrington (the Chair) and Louise Zonko (Topic Group Lead) facilitated the discussion of the evidence and the committee drafted recommendations.

5. Economics evidence related to G1 and G2 -presentation / update

James Hawkins, NGA Senior Economist presented the economic evidence and model related to this topic.

6. Edited recommendations: Section 1.5 The role of social workers within multidisciplinary teams and how they communicate, support and work with others

Katharina Dworzynski, NGA Guideline Lead, provided an overview of the editorial comments.

The committee clarified the queries from the editor and changes to recommendations were made accordingly and signed-off.

7. Updating searches for evidence- prioritisation of topics

Jen Francis, NGA Senior Systematic Reviewer provided an overview of previous topics and suggested topics where updating of searches would be important. The committee discussed the options and decided which of the topics should be updated.
