1. Welcome and objectives for the meeting

4. Evidence review: Cochrane: psychological treatments for epilepsy

The Cochrane review team presented the clinical evidence review on psychological treatments for people with epilepsy. AB presented the potentially includable health economic evidence for this subject, but the committee decided the study was not of sufficient methodological quality to include. The committee's discussion of the evidence followed the presentation and the committee drafted recommendations. The summarised discussion will be circulated for the committee's further consideration at a later meeting.

5. Health economics: Modelling methods presentation

AB delivered a presentation on modelling methods, for the committee's information.

6. Summary of committee discussion: Monitoring

The draft recommendations and summary of the committee's discussions on the monitoring evidence review presented at a previous meeting was discussed by the committee and edits made during the meeting.

Due to time constraints the committee was unable to complete revision of the information and support and referral for surgery summary evidence discussions. These items will be revisited at a later meeting.
