#### 1. Welcome and objectives for the meeting

The Chair welcomed the Committee members and attendees to the second meeting on Epilepsies in children, young people and adults.

- Presenting, discussing and editing draft review protocols for the areas of the guideline to be commissioned to Cochrane and protocols that will be reviewed by the NGC Epilepsies technical team.
- Discussing the economic priorities for the guideline.

Jacqui Real delivered a methodological presentation on the measurement of minimum important differences that will be used when considering outcomes reported in evidence reviews across clinical areas addressed within the guideline. The committee had an opportunity to discuss and agree on appropriate MIDs for a range of clinical outcomes. The Chair co-led discussions and presented a diagram to support the presentation.

# 6. Draft Review Protocols: Cochrane commissions

Angela Cooper presented draft protocols for reviews on the following topics. The committee discussed and amended the protocols, with the assistance of the Cochrane epilepsy reviewing teams who had joined the meeting remotely:

- Protocol 5.2. Effectiveness of ketogenic diet: Update of Cochrane review effectiveness of a ketogenic diet in drug resistant epilepsy
- Protocol 7.2. Effectiveness of psychological interventions: Update of Cochrane review psychological treatments for people with epilepsy

# 7. Health economic priorities

Margaret Constanti delivered a presentation on cost effectiveness and decision analytic modelling. The committee was then led through a discussion on the health economic modelling prioritisation and the economic plan. Committee members considered the suggested priorities for this guideline.

# 8. Draft Review Protocols: reviews

Angela Cooper and Jacqui Real presented draft protocols for upcoming reviews on the clinical area listed below, the committee discussed and amended the protocol:

• Protocol 3.8 a&b: Effectiveness of AEDs in the treatment of status epilepticus

These reviews will be completed by the NGC technical team. The Chair asked for volunteers to support the draft work on this area.
