The Chair thanked Odette for her presentation.

#### Afternoon presentations

The Chair introduced Odette Megnin-Viggars, NGA Senior Systematic Reviewer who gave a presentation on the *Reruns for Evidence review 1.1: For adults with depression, what are the relative benefits and harms associated with different models for the coordination and delivery of services? )?* 

Odette presented the updated clinical evidence and took questions from the group. The Chair thanked Odette for her presentation.

The Chair introduced Odette Megnin-Viggars, NGA Senior Systematic Reviewer who gave a third presentation on the *Reruns for evidence review 3.0: For adults at risk of depression (or anxiety disorders) from particular vulnerable groups (older people, black minority ethnic groups, lesbian, gay bisexual, transgender groups and men) do service developments and interventions which are specifically designed to promote access, increase the proportion of people from the target group who access treatment, when compared with standard care?* 

Odette presented the updated clinical evidence and took questions from the group. The Chair thanked Odette for her presentation.
