IM explained the principles for the inclusion of an intervention in a systematic review or a NMA followed by the merits and limitations of the NMA.

IS presented the review questions relating to service delivery and asked the GC to confirm the outcomes.

The GC were asked to consider whether the setting of the intervention will need to be altered for the different levels of severity of depression and whether older adults should be a specific subgroup for services?

IM presented the rest of the review questions and were asked to consider key outcome measures for each.

A NMA topic group was selected.

IM presented the draft health economic plan.

7. Other issues

A Committee member enquired about the mapping of services. The mapping of services is beyond the remit of the scope, CCQI will be contacted to see what data they have.

The GC continued to approve the idea of a NMA.

The literature search identified a very large number of studies to sift through.
