1. Welcome, apologies, introductions and objectives

The Chair welcomed the Committee members and attendees to the 16th meeting on Social, emotional and mental wellbeing in primary and secondary education.

The Chair asked those present to introduce themselves. The Chair informed the Committee that apologies had been received, these are noted above.

2. Confirmation of matter under discussion, and declarations of interest

The Chair confirmed the matter under discussion and asked everyone to verbally declare any new conflicts of interest. No new interests were declared.

The Chair advised that the interests previously declared did not prevent the attendees from fully participating in the meeting.

3. Health economics – Cost-effectiveness search re-runs and Presentation of final model

The Chair welcomed Laura Coote who presented new evidence identified by rerunning the cost-effectiveness literature searches. LC explained how the newly identified evidence fit with that previously presented. The committee discussed the impact of the new evidence on draft recommendations.

Committee member MW reminded the Chair of a previously declared interest in relation to the cost-effectiveness re-run presentation. The Chair confirmed that the interest did not prevent MW from fully participating in the meeting.

LC then presented to the committee the final version of the health economic model developed to inform the guideline. The committee were then given an opportunity to ask questions to inform it's drafting of recommendations.

4. Implications of HE model on draft recommendations

The Chair introduced Lesley Owen who discussed further with the committee the impact of the health economic model outputs on the draft recommendations.

5. Review Question 3.2: Are universal classroom-based interventions acceptable to the children and young people receiving them, their parents or carers and to those delivering them?

Review Question 3.3: What are the barriers and facilitators to using universal classroom-based interventions to promote social, emotional and mental wellbeing in children and young people?

The Chair welcomed Giacomo De Guisa, who presented the effectiveness evidence identified for Review Questions 3.2 and 3.3 on Universal classroom-based interventions

The Committee discussed the evidence and had the opportunity to ask questions before recommendations were drafted.

6. Any outstanding business

The committee revisited Expert witness Rachel Tomlinson's presentation from the previous day and discussed potential draft recommendations.
