1. Welcome, apologies, introductions and objectives

Review Question 3.1b: What universal classroom-based interventions to promote social, emotional and mental wellbeing in children and young people in secondary and further education are effective and cost effective?

Review Question 3.2: Are universal classroom-based interventions acceptable to the children and young people receiving them, their parents or carers and to those delivering them?

Review Question 3.3: What are the barriers and facilitators to using universal classroom-based interventions to promote social, emotional and mental wellbeing in children and young people?

The Chair introduced Giacomo De Guisa, who presented the effectiveness evidence identified for the review questions on Universal Curriculum and answered questions from the committee.

The Chair introduced Cathy Creswell, Psychologist and Professor of Developmental Clinical Psychology, who presented the committee with expert testimony on the impact of COVID-19 on education and child development.
