# 1. Welcome and objectives for the meeting

The Chair introduced Rachel Connolly, NGA Systematic Reviewers who gave a presentation on Review question *7.2, What is the effectiveness of therapeutic risk-taking strategies for people who have self-harmed?* Rachel Connolly took questions from the group. The Chair thanked Rachel for her presentation.

The Chair introduced Nathan Bromham, NGA Senior Systematic Reviewer who gave a presentation on Review question 2.3, What are the most effective models of care for people who have self-harmed? The presentation consisted of the Clinical evidence, Cost effectiveness evidence and drafting recommendations based on this. Nathan Bromham took questions from the group. The Chair thanked Nathan for his presentation.

#### Afternoon presentations

The Chair introduced Ferruccio Pelone, NGA Economist who gave a presentation on the Health Economics for Review question *5.2, What psychological and psychosocial* interventions (including safety plans and electronic health-based interventions) are effective for people who have self-harmed? Ferruccio Pelone took questions from the group. The Chair thanked Ferruccio for his presentation.

The Chair, Jeremy Isaacs and Katherine Andrea, NGA Guideline Lead spoke to the group to Review and edit recommendations for the following: 2.1 – Brief recap of the evidence, 2.2 and 3.1 – Education.
