1. Welcome and objectives for the meeting

The Chair welcomed the Committee members and attendees to the 2nd guideline committee meeting on Self Harm: assessment, management and preventing recurrence. This committee meeting is the first virtual meeting held over Zoom.

This guideline committee meeting is the first meeting to be held post the Coronavirus pandemic. Three committee meetings between March to June were cancelled due to the lockdown.

The Chair informed the Committee that no apologies had been received.

The Chair reminded all present that the Committee is independent and advisory, that its decisions and recommendations to NICE do not represent final NICE guidance, and that they may be changed as a result of public consultation.

The Chair outlined the objectives of the meeting, which included introducing the NGA team, committee members re-introducing themselves and introducing the newly recruited committee lay member. The Chair also discussed the meeting etiquette for the virtual meeting.

4. Presentations
