1. Welcome and objectives for the meeting

The Chair welcomed the committee members and attendees to the 17th meeting on multiple obstetric guidelines update.

The Chair informed the committee that there were no apologies received.

The Chair outlined the objectives of the meeting, which included reviewing guideline protocols, a Cochrane review and making recommendations.

2. Confirmation of matter under discussion, and declarations of interest

The Chair confirmed that, for the purpose of managing conflicts of interest, the matters under discussion were multiple obstetric topics including Intrapartum care (IPC) and Ectopic pregnancy and miscarriage (EPM).

The Chair asked everyone to verbally declare any interests that have risen since the last meeting. New interests were declared and noted below.

3. Minutes of last meeting

The Chair asked the committee to confirm the minutes of the last meeting, and the committee confirmed that no changes were required.

The actions and decisions log from guideline committee meeting 16 was reviewed and confirmed by the committee. Some pending actions were discussed.

4. Morning presentations

The Chair introduced Maggie Blott, Topic Advisor, who presented the outline and rationale of the IPC guideline scope.

The Chair introduced Eva Gonzalez, NGA Senior Systematic Reviewer, who presented a brief overview of the IPC review questions and the general principles of protocols.

5. Afternoon presentations

The Chair introduced Agnesa Mehmeti, NGA Systematic Reviewer, who presented the review protocol for:

IPC Q3.1: What is the effectiveness of water papules for pain relief during labour?

IPC Q3.2: What is the effectiveness of opioids administered by intravenous patient-controlled analgesia (PCA) compared to intramuscular administration?

The Chair introduced Claire Maynard, NGA Systematic Reviewer, who presented the

review protocol for IPC Q8.1: What are the benefits and risks associated with active management compared to physiological management in the third stage of labour?

The Chair introduced Dr Adam Devall, Dr Ioannis Gallos and Prof Arri Coomarasamy, Cochrane Review Authors from the University of Birmingham, who presented their Cochrane review and meta-analysis for the EPM guideline: Progestogens for preventing miscarriage: a network meta-analysis.

6. Questions and discussions

The committee revised and signed off the IPC Q3.1 and 3.2 protocols. The committee also discussed the Cochrane review on the EPM guideline and made recommendations.

7. Any other business

The Chair introduced Hilary Eadon, NGA Guideline Lead, who presented the updated topic group list and asked the committee to confirm if they are happy with the groups they have been assigned to and inform the NGA team if they would like any changes made to their assigned groups.

The Chair reminded the committee of the IPC committee meeting dates and informed the committee that they will be sent a list of dates that have been confirmed for 2021.

Hilary Eadon reminded the committee that there are two committee meetings in July but one will be the post-consultation meeting for the Inducing labour guideline and will be held with the previous committee.
