1. Welcome and objectives for the meeting

The Chair welcomed the Committee members and attendees to the ninth meeting on Head Injury (update). Apologies were announced and are noted above.

The Chair outlined the objectives of the meeting, which included the following:

- Presenting the tranexamic acid health economic model methods.
- Presenting the evidence review on indications for admission in small intracranial injuries.
- Reviewing the draft research recommendations for: direct access to imaging and admission and observation for concussion.

2. Confirmation of matter under discussion, and declarations of interest

The Chair confirmed that, for the purpose of managing conflicts of interest, the matter under discussion was tranexamic acid health economic model, indications for admission in small intracranial injuries, direct access to imaging and admission and observation for concussion.

3. Declarations of interest

The Chair and a senior member of the Developer's team confirmed that based on previously recorded declarations the following applies:

5. Presentation: Tranexamic acid health economic model methods.

DW delivered a presentation on the methods used to produce the economic model on tranexamic acid. The committee heard that the economic subgroup would consider feedback and a further refined copy of the model will be presented at a future meeting.

6. Evidence review: Indications for admission in small intracranial injuries

ND/DW delivered a presentation on indications for admission in small intracranial bleeding. The committee considered the evidence and it was agreed to continue discussions at a future meeting.

FL stayed in the room but did not participate in the discussion of the recommendations.

7. Draft research recommendations

Draft research recommendations were presented and discussed for the following topics: direct access to imaging and admission and observation for concussion. It was agreed to not proceed with drafting these research recommendations.
