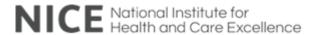

The Chair introduced Nathan Bromham, NGA Senior Systematic Reviewer who gave a presentation on Protocol for draft review question: 6.5 How effective is corticosteroid therapy in managing the neurological consequences of metastatic spinal cord compression? And a further presentation on Protocol for draft review question: 6.1 How effective are analgesic interventions in managing pain related to spinal metastases, direct malignant infiltration of the spine or associated spinal cord compression? Nathan Bromham took questions from the group. The Chair thanked Nathan for his presentations.
