3.0 Guideline development: before consultation (to be completed by the Developer before consultation on the draft guideline)

3.1 Have the potential equality issues identified during the scoping process been addressed by the Committee, and, if so, how?

Terminology has been altered in line with Stakeholder suggestions. Note that the change has not necessarily been precisely as indicated in section 2.2. "Hemisensory inattention" does not, on reflection, serve as a replacement for "visual neglect" since it can apply to other sensory disturbances. We have used the term "visual inattention" after discussion with Topic Advisor.

- 3.2 Have any **other** potential equality issues (in addition to those identified during the scoping process) been identified, and, if so, how has the Committee addressed them?
- Race: A recommendation has been made to consider the use of computer-based tools as an adjunct to conventional speech and language therapy for the purpose of helping people with word finding problems. The committee have noted in the discussion that the currently available programs do not cover those whose first language is not English. The Committee have acknowledged the problem but addressing it fully will be in the hands of the program developers. However, the program which was used in the main UK study (StepbyStep) does allow personalised wording to be added and family members of the Stroke survivor could therefore introduce words in the required language.
- Socio-economic factors: The recommendations on use of telerehabilitation will be
 easier to implement for people who can afford home computers or already
 possess one. It is also noted however, that for some people the cost of this will
 be offset by the removal of the need to travel to receive the relevant therapy. It
 will be necessary to weigh these factors against one another in individual cases.

Disability

A stakeholder has made a number of comments suggesting that the guideline should include more about making reasonable adjustments for those with disability, particularly learning difficulties and autism. We have added a cross-reference to NG96: care and support of people growing older with learning disabilities.

Race

In one comment a stakeholder suggests the guideline says more about how to ensure services are accessible to people with disabilities (see above) and BAME communities. The guideline already includes several recommendations which emphasise the importance of personalising rehabilitation and these are relevant to accommodating all ethnic groups. NICE's guidance on patient experience in adult NHS services comprehensively covers the importance of tailoring management to each individual and we have added a cross reference to this in recommendation 1.17.6 (which deals with community participation programmes).
