## 1. Welcome, introductions and objectives for the meeting

The Chair welcomed the Committee members and attendees to the ninth meeting of the Stroke rehabilitation (update) committee.

The Chair informed the Committee that apologies had been received. These are noted above.

The Chair outlined the objectives of the meeting, which included: review evidence for spasticity and self-care management; agree the protocol for the shoulder pain evidence review.

# 2. Confirmation of matter under discussion, and declarations of interest

The Chair confirmed that, for the purpose of managing conflicts of interest, the matters under discussion were spasticity, self-care management and shoulder pain.

The Chair asked everyone to verbally declare any interests that have arisen since the previous meeting.

CF has accepted an external examinership at Glasgow University. It was agreed that this does not need to be formally declared.

JBe is a principal investigator for the PHEAST (Pharyngeal Electrical stimulation for Acute Stroke dysphagia Trial). SH is a member of the steering group for PHEAST. JBe and SH can declare and participate. JBe will highlight any studies from PHEAST if they are included in our evidence reviews.

The register of interests was reviewed prior to the meeting. The Chair and Guideline Lead confirmed that the interests declared did not prevent the attendees from fully

participating in the meeting.

## 3. Evidence review: spasticity

MZ presented the clinical effectiveness evidence for spasticity. KL presented the cost effectiveness evidence on behalf of CS. The committee discussed the evidence and provisional draft recommendations. The provisional recommendations will be revisited once modelling work has been completed.

## 4. Draft protocol: shoulder pain

GW presented the draft protocol for the shoulder pain evidence review. The committee discussed and agreed the final protocol.

## 5. Evidence review: self-care management

TS and CS presented the clinical and cost effectiveness evidence for self-care management. The committee discussed draft recommendations.

## 6. Interim publication of research recommendations

The possibility of publishing some guideline content prior to the full publication was discussed within NICE. BH and RF reported back to the committee that it had been decided not to proceed with interim publication.
