- 1. Introductions and apologies. MM welcomed the group to the third meeting of this GDG. Apologies were heard from SA.
- 2. Declarations of Interests (DOIs). The Chair asked all GDG members to declare any relevant conflicts of interest since GDG 2. The following DOIs were noted from MM: he is secretary of the National Blood Transfusion committee, is clinical director for NHS blood and transplant and also leads the blood transfusion team in Oxford, a team which has developed electronic blood management systems to support transfusion in the NHS. The following DOIs were noted from DT: he Chairs the Network for alternatives to transfusion (NATA). The following DOIs were noted for TW: he is the UK Chief Investigator for the National Institute for Health Research (NIHR) Health Technology Assessment (HTA) funded ABLE study (Age of Blood Evaluation Study).
