- 3.4d What antibiotic treatment regimens are effective in treating bacterial meningitis caused by Gram-negative bacilli?
- 3.4e What antibiotic treatment regimens are effective in treating bacterial meningitis caused by Listeria monocytogenes?
- 3.4f What antibiotic treatment regimens are effective in treating bacterial meningitis caused by Neisseria meningitidis?
