Specifically, the research recommendations we will draft based on areas where we were only able to make minimal, if any, recommendations due to a lack of evidence and existing research.

CM presented her suggestions and then asked the committee for their priorities and opinions.

The Chair thanked CM for her work in preparing for this presentation and moved on to the next item on the agenda.

4. Responding to stakeholder comments

For the remainder of the day, CM continued to present to the committee, taking them through the broad themes around stakeholder comments, suggesting possible responses to said comments, and suggesting changes to the recommendations where necessary.

The committee offered their opinions over a lengthy and detailed discussion, making their own suggestions to drafted responses/changes already created by the development team, before the Chair brough this section to a close – thanking CM and the rest of the team for their hard preparatory work and the committee for their exhaustive input.
