# Using this information

This information accompanies the NICE guideline on overweight and obesity management (NG246, published January 2025).

The overweight and obesity management guideline brings together the following NICE guidelines and replaces them:

- Preventing excess weight gain (NG7, 2015)
- Obesity: identification, assessment and management (CG189, 2014)
- Weight management: lifestyle services for overweight or obese adults (PH53, 2014)
- Weight management: lifestyle services for overweight or obese children and young people (PH47, 2013)
- BMI: preventing ill health and premature death in black, Asian and other minority ethnic groups (PH46, 2013) – already updated and replaced by CG189
- Obesity: working with local communities (PH42, 2012)
- Obesity prevention (CG43, 2006).

The following tables show whether recommendations from each source guideline were deleted or carried forward into the updated guideline, and the year that the evidence was last reviewed. Changes to recommendations as a result of evidence review or committee discussion, or to reduce duplication as part of amalgamating the guidelines, are also explained in this table. Minor wording changes to update terminology and match our current way of writing recommendations, but which do not affect the intent of the recommendation, are not listed.

In the tables, the year column shows when the evidence for each recommendation was reviewed. In the updated guideline, the year given at the end of the recommendations (for example **[2006]**) shows when the source guideline containing that recommendation was published and is when the evidence for that recommendation was last reviewed. Any recommendations that have been updated as a result of committee discussions but without a review of the evidence are marked **[(year of original guideline), amended 2025]**.

New recommendations made after a review of the evidence are marked **[2025]**.
