**1. Welcome and objectives for the meeting**

The Chair welcomed the committee members and attendees to the 7<sup>th</sup> meeting on multiple obstetric guidelines update. The committee members and attendees introduced themselves.

The Chair informed the committee that apologies had been received from Pensee Wu.

The Chair outlined the objectives of the meeting, which included: developing protocols, reviewing evidence and making/revising recommendations.

**2. Confirmation of matter under discussion, and declarations of interest**

The Chair confirmed that, for the purpose of managing conflicts of interest, the matters under discussion were multiple obstetric topics on ectopic pregnancy (EP), and preterm labour and birth (PTLB).

The Chair asked everyone to verbally declare any interests that have risen since the last meeting. New interests were declared and noted below.

The Chair and Guideline Lead noted that the interests declared in the registry did not prevent the attendees from fully participating in the meeting.

### 3. Minutes of last meeting

The Chair asked the committee to confirm the minutes of the last meeting, and the committee confirmed that no changes were required.

The action and decision log from Guideline committee 6 was reviewed by the committee and one correction noted – Under Item 5 it had been noted ‘...that women with BMI over 30 kg/m<sup>2</sup> (which accounts for over 75% of the population of women that are seen by clinicians)...’

This should be corrected to ‘...that women with BMI over 30 kg/m<sup>2</sup> (which accounts for over 50% of the population of women who require Caesarean section)...’

#### **4. Morning presentations**

##### **Stakeholder comments received on ectopic pregnancy guideline:**

Hilary Eadon presented the stakeholder comments that had been received for the ectopic pregnancy guideline update.

##### **Discussion of protocol IoL1:**

Katie Webster presented the draft protocol for review question:

IoL1: What are the harms and benefits of induction of labour in women with suspected fetal macrosomia?

#### **5. Afternoon presentations**

##### **Discussion of protocol CS1:**

Katie Webster presented the draft protocol for review question:

CS1: What are the risks and benefits (short and long term) of planned caesarean section compared with planned vaginal birth at term for women and neonates/infants/children?

##### **Evidence review of question PTLB1:**

Eva Gonzalez presented the evidence review for question PTLB1: What is the clinical effectiveness of prophylactic progesterone (vaginal or oral) in preventing preterm labour in pregnant women considered to be at risk of preterm labour and birth?

#### **6. Questions and discussions**

The committee made some revisions to the recommendations in the EP guideline in light of stakeholder comments, and drafted responses to the comments.

The committee discussed the protocols for IoL1 and CS1 and agreed that they were now finalised and could be signed off.

The committee discussed the evidence presented for PTLB1 and made recommendations.

The committee also discussed the NICE editor's suggested changes the recommendations for question CS2: What methods, apart from prophylactic antibiotics, should be used to reduce infectious morbidity in women undergoing CS?

#### **7. Any other business**

Hilary Eadon informed the committee that there had been some changes to the

dates of future meetings and explained the new meeting schedule.
