- 2. There were the following new declarations of interest: TC declared a non-pecuniary, personal interest with regards to a meeting in June for an attachment research group for Virtual Heads (see page 3).
- 3. The minutes from the previous meeting were reviewed for accuracy and confirmed. The plan for the day was outlined. The first half would be presenting evidence and the second half would be looking at the edited version of the guideline.
- 4. Care leavers and carer representatives were asked to express any concerns of which there were none.
- 5. Environmental risk factors for carers and adoptive parents had been looked at in response to GDG concern. 14 papers were found for this search and a number did look at attachment specifically for children in care. Details of each study were outlined.
- 6. An update was provided on measurements/tools for identification and prediction. Discussion followed.
- 7. The NICE Editor presented to the group. He explained which other versions of the guideline would be produced and briefly outlined the editorial meeting that happens later in development. How the Editor will support the guideline committee throughout the development process was also explained.
- 8. All of the recommendations (the short version of the guideline) were reviewed. Amendments were made following discussion.
- 9. The CG agreed to keep the key priorities for implementation. The ten from the original version of the guideline were reviewed.
- 10. The next steps, leading up to submission for stakeholder consultation, were outlined. Working alongside NICE, and in response to internal comments, the technical team would make any relevant changes to the guideline accordingly. Revised versions of both the full and short versions of the guideline would be circulated to the CG for comment in due course.
