The review questions would be used to guide the systematic review work, which in turn would guide the GDG in the development of recommendations.</p> <p>The GDG discussed each question in depth and suggested and agreed amendments.</p> <p>KS thanked the GDG for their contribution in refining the review questions. JF would now work on a revised set and these would be circulated to the GDG and agreed with NICE within the next 2 weeks.</p>	<p>ACTION 3: JF will liaise directly with PO’N after the GDG to work on draft wording for question(s) and will then circulate drafts to the GDG.</p>
