The committee identified the following potential equality issue:

Support and education would be useful for women with language difficulties as well as those with learning disabilities. Based on this, the committee retained existing recommendations and expanded them to state that for pregnant women who are using flash or continuous glucose monitoring, a member of the joint diabetes and antenatal care team with expertise in these systems should provide education and support.

3.3 Have the Committee's considerations of equality issues been described in the guideline for consultation, and, if so, where?

Yes – in the "other factors the committee took into account" section of the committee's discussion of the evidence.

3.4 Do the preliminary recommendations make it more difficult in practice for a specific group to access services compared with other groups? If so, what are the barriers to, or difficulties with, access for the specific group?

The committee did not identify anything in the preliminary recommendations to make it more difficult in practice for a specific group to access services compared with other groups. The committee identified that women using flash or continuous glucose monitoring with language difficulties or learning disabilities would benefit from support and education from the joint diabetes and antenatal care team.

The committee gave careful consideration to advancing equality in all updated recommendations. Certain groups such as those with language difficulties and learning disabilities were identified. Committee discussions around equality issues have been added to the evidence review for continuous glucose monitoring.
