1. Welcome and objectives for the meeting

The Chair welcomed the Committee members and attendees to the 9th PHAC meeting on 'Sunlight Exposure – benefits and risks' and the 12th meeting of PHAC F.

The Chair welcomed the members of the public to the meeting. The members of the public had been briefed already, both verbally and in writing by the NICE team, and the Chair reminded them of the protocol for members of the public, whose role is to observe (they should not speak or ask questions). No filming or recording of the meeting is permitted. The Chair reminded all present that the Committee is independent and advisory, that its decisions and recommendations to NICE do not represent final NICE guidance, and that they may be changed as a result of public consultation.

The Chair informed the Committee that apologies had been received. These are noted above.

The Chair outlined the objectives of the meeting as follows:

- To consider stakeholders comments on the draft guideline
- To consider the equality impact assessment of the guideline
- To discuss revisions and finalise the guideline

2. Confirmation of matter under discussion, and declarations of interest

The Chair confirmed that, for the purpose of managing conflicts of interest, the matter under discussion was **Sunlight Exposure**: **communicating the risks and benefits to the general population**.

4. Update on guideline development

Adrienne Cullum, technical lead for this guideline, updated the committee on the following:

- Actions since the last meeting
- Overview of stakeholder comments
- An update on the Scientific Advisory Committee on Nutrition (SACN) report on vitamin D.

Catherine Law thanked stakeholders for commenting for a second time on the draft guideline, and assisting the committee with clarifying the guideline.

Tracey Shield, senior technical analyst for this guideline, then updated the committee on the Equality Impact Assessment.

5 Questions and discussion

The committee had an opportunity to discuss some of the overarching issues about the guideline. These included:

- Whether the guideline should address specific age groups such as children and young people
- The draft recommendations made by SACN on vitamin D

6 and 7 Update: SACN - vitamin D working group

Mamta Singh from Public Health England gave a brief update on the work of SACN on vitamin D.

The committee were given an opportunity to ask any questions about the draft SACN report.

8, 9 and 10 Revising the guideline

The committee then looked in turn at all of the sections in the guideline and suggested changes based on the stakeholder feedback. They discussed:

- The implications of the draft SACN report on vitamin D
- Sunscreen
- Each of the recommendations
- All other sections of the guideline

Action: PHAC members to provide various references for the guideline and to confirm figures stated in the context section.

11. Summary of the day and next steps

Adrienne Cullum outlined the next steps as follows:

- The PHAC to be sent the next iteration of the guideline for consideration between 22nd October and 5th November 2015.
- The guideline will then be revised and will have a number of internal quality

assurance steps before publication, which is currently set for 9th February 2016.

• **Action:** The committee should be updated about the process for responding to any press enquiries.

The Chair noted that this was her penultimate meeting of PHAC F, and her final meeting to discuss the sunlight guideline. The new chair of the committee and the vice chair would therefore be taking over finalising this guideline after the end of October. She thanked the members for their work on this guideline.
