1. Welcome and objectives for the meeting

The Chair welcomed the Committee members and attendees to the 12th meeting on Harmful Sexual Behaviour. The Committee members and attendees introduced themselves.

No members of the public asked to observe the meeting.

The Chair informed the Committee that apologies had been received. These are noted above.

The Chair outlined the objectives of the meeting, which included:

- Receive an update on the final draft of review two on 'identification' including any additional analysis;
- To hear a presentation on the economic plan and draft model;
- Hear a range of expert testimonies on the topic of harmful sexual behaviour and to confirm expert testimony planned for the November PHAC.

Introductions

2. Confirmation of matter under discussion, and declarations of interest

The Chair confirmed that, for the purpose of managing conflicts of interest, the matter under discussion was *Harmful Sexual Behaviour: identifying and helping children and young people who display harmful sexual behaviour*

The Chair asked everyone to verbally declare any interests that have arisen since the last meeting.

No new interests were declared.

3. Minutes of last meeting

The Chair asked the Committee if it wanted any changes made to the minutes of the last meeting. The Committee agreed that the minutes were a true and accurate

account of the meeting.

The Chair confirmed that all matters arising had been completed or were in hand.

4. Presentations

The Chair introduced Fiona Campbell, ScHARR, who gave a presentation on final review two on identification. This included information on additional analysis.

The Committee then discussed the issues presented in relation to this guideline. The Chair thanked Fiona for her presentation.

The Chair introduced Clive Pritchard, Optimity Matrix, who gave a presentation on the economic review and draft model.

The Committee then discussed the issues presented in relation to this guideline. The Chair thanked Clive for his presentation.

The Chair introduced Dr Eileen Vizard, New York University, who gave a presentation on children and young people with troubling behaviours/personality disorders who display harmful sexual behaviours.

The presentation focussed on the natural history of troubling behaviours/personality disorders and young people with harmful sexual behaviour and co-morbid mental health issues.

Dr Vizard took questions from the group.

The Chair introduced Professor Jane Silovsky, University of Oklahoma. Professor Silovsy joined the meeting via teleconference and gave a presentation on children under 10 displaying harmful sexual behaviour.

The presentation focussed on the potential harms associated with early identification of harmful sexual behaviour in this age group and the impact of legislation and the association with sex offender status. The presentation also looked at interventions developed for this age group compared to more generic interventions for children displaying harmful sexual behaviour.

Professor Silovsky took questions from the group.

The Chair introduced Sharron Wareham, Barnardos, who gave a presentation on Barnardo Taith project for girls.

The presentation focussed on the development of standardised assessment tools and intervention resources for girls who have engaged in harmful sexual behaviour. In particular, Sharron discussed how the approach was developed and what the indicators of success are and how it differs from more orthodox CBT approaches.

Ms Wareham took questions from the group.

The Chair introduced Peter Clarke, Glebe House, who gave a presentation on the Glebe House model.

The presentation focussed on the development of the Glebe House model and learning to date. The presentation looked at the voice of children and young people as service users and residential issues relevant to this group.

Mr Clarke took questions from the group.

The Committee thanked the experts for their presentations and contribution to the development of the guideline.

5. Questions and discussion

The Committee discussed the draft recommendations and considerations from review 2, the economic report and model and the expert testimony, and were given the opportunity to ask questions.

The Committee discussed the suggested evidence, including gaps and expert testimonies, and were given the opportunity to ask questions.

6. Other issues

Rachel Kettle gave a brief introduction to the NICE pathways system. She informed the Committee that representatives from the Pathways team will be attending the next meeting. She explained that the Pathways team would like some members of the Committee to volunteer to help with the development of the pathway.
