2. The chair highlighted the aims of the day, which were acquainting the GDG with the GMS system, Re-examining the review questions, understanding areas of overlap with PHIP guideline, developing understanding of criminal justice system pathway.
3. New declarations of interest were received from Julie Tabreham, Mark Warren and Leroy Simpson.
4. The minutes and related actions from the previous GDG were reviewed and accepted.
5. A female service user has been identified and will be invited to join the GDG.
6. Noted that service user concerns will be felt by any carers as well.
7. MM, the Project Manager for NCCMH, gave a brief training on the GMS, the Guideline Management System.
8. ES gave a presentation on Health Economics and the draft HE plan.
9. TH, the research assistant on this guideline, gave presentation 'Search for evidence: Initial results' and identified that there are minimal randomized controlled trials available.
10. The GDG discussed the draft pathway presented which focused on 'in prison'. It was agreed that a re-draft would be carried out using the 'Offender Mental Health Care Pathway (2005) as a starting point.
11. RBr, the Physical Health in Prisons guideline chair, gave presentation on the overview of the Physical Health in Prisons guideline.
12. TH, the research assistant on this guideline, gave a presentation on the review questions and protocols to make any modifications and gain approval.
13. The service users confirmed that it would be helpful if all acronyms were explained as the meetings progressed.
