1. Welcome and objectives for the meeting

4. Pregnancy related outcomes

The Chair introduced Adrienne Cullum, Technical Lead at NICE, who gave a presentation on the additional work NICE had undertaken on pregnancy related outcomes.

Adrienne took questions from the group.

The committee discussed the UK observational papers on multicomponent schemes that NICE had identified. It was noted that only one of these was published in a peer reviewed journal (Cheetham et al) and this was included in the PHE/ Brook guide on C card schemes.

The Chair thanked Adrienne for her presentation and contribution to the development of the guideline.

5. Updated evidence review and evidence statements

The Chair introduced Josephine Kavanagh, Technical Analyst at NICE, and Chris Carmona, who gave a presentation on the updated evidence review and evidence statements.

The Committee discussed the evidence in relation to the guideline and were given the opportunity to ask questions.

The Chair thanked Chris and Jo for their presentation and contribution to the development of the guideline.

Action: NICE to make additional minor amends for clarity.

6. Submitted written testimony

The Chair reminded the committee that they had received testimony from Owen Brigstock Barron at the previous meeting but that Rob Cookson had been unable to attend due to travel problems. Both had submitted written testimony for consideration by the committee.

The Committee discussed the written testimony in relation to the guideline and were given the opportunity to ask questions.

The Chair thanked Owen Brigstock Barron and Rob Cookson for their submitted testimony.

Action: ScHARR to consider systematic review referenced by Rob Cookson to check if any useful references.

7. Economic modelling

The Chair introduced Susi Sadler, Research Fellow in Health Economics at ScHARR, who gave a presentation on the economic model.

The Committee then discussed the issues presented in relation to this guideline and were given the opportunity to ask questions.

The Chair thanked Susi for her presentation.

Action: ScHARR to undertake some additional modelling and update the modelling report in line with the committee discussion.

8. Drafting guideline recommendations and committee discussion

The Committee drafted guideline recommendations and research recommendations based on the evidence presented.

Action: NICE to draft recommendations, research recommendations and other guideline sections based on committee discussion.

Action: NICE to circulate redrafted recommendations and research recommendations by the middle of the following week for committee comment by Monday 16th May.

9. Equality Impact Assessment

The Chair introduced Adrienne Cullum, Technical Lead at NICE, who gave a presentation on the equality impact assessment.

Adrienne took questions from the group.

The Chair thanked Adrienne for her presentation and contribution to the development of the guideline.

Action: NICE to update the EIA based on committee discussion.

10. Summary of the day and next steps

The Chair summarised the discussion from the day and highlighted that the next meeting on this topic would take place on 4th October 2016.

All committee members were reminded that expenses must be submitted within 3 months of a meeting taking place.
