1. Welcome and objectives for the meeting

The Chair welcomed the Committee members and attendees to the eighth meeting of the Eating Disorders Guideline Committee.

No members of the public asked to observe the meeting.

The Chair informed the Committee that apologies had been received. These are noted above.

Introductions

There were no additional introductions.

2. Confirmation of matter under discussion, and declarations of interest

The Chair asked everyone to verbally declare any conflicts of interest that have arisen since the last meeting.

Tim Kendall, Clinical Director advised the committee he had been appointed as National Clinical Director of Mental Health. After discussion with the committee the group agreed this was an acceptable interest and no further action was required.

3. Minutes of last meeting

The Chair asked the Committee if it wanted any changes made to the minutes of the last meeting. The Committee agreed that the minutes were a true and accurate account of the meeting.

4. Presentations

The Chair introduced Eric Slade, Health Economist who led a discussion on the

network meta-analysis for Bulimia Nervosa and Binge Eating Disorder. Provisional results were presented. This was followed by a discussion on considerations for economic modelling including the cost of treatment for BN and BED.

The Chair introduced Leanne Saxon, Systematic Reviewer, who clarified the classification of a number of studies on psychological interventions for Anorexia Nervosa with the Guideline Committee. This was followed with a presentation of the evidence on comorbidities and eating disorders.

The Chair introduced Linyun Fou, Research Assistant who presented evidence on compulsory treatment for people with eating disorders.

A general discussion on the contributions from Guideline Committee members to the introductory chapter for the guideline concluded the meeting.

The Committee then discussed the issues presented in relation to this guideline. The Chair thanked the technical team for their presentations.

5. Questions and discussion

The Committee discussed the evidence presented on comorbidities and clarified with (CM) the scope for this guideline did not include looking at the modification of interventions for common physical long-term health conditions in the presence of an eating disorder.

The Committee discussed the evidence on factors that need to be considered when assessing whether a person with an eating disorder should be admitted for compulsory treatment and agreed to form a sub-group to focus on a consensus recommendation on this.
