1. Welcome and objectives for the meeting

Christopher Fairburn declared that he was a co-author of one of the studies reviewed for the comorbidities of ED and another for the assessment and monitoring review. CF withdrew from the discussions and only answered questions in relation to the studies.

Glenn Waller declared that he was involved in studies included in the assessment and monitoring review. GW withdrew from the discussion and only answered questions in relation to the studies.

Lee Hudson declared that he was co-author on one of the studies included in the physical complications review. LH withdrew from the discussion and only answered questions in relation to the study.

Dasha Nicholls declared that she was co-author on one of the studies included in the physical complications review. DN withdrew from the discussion and only answered questions in relation to the study.

Hannah Turner declared that she was involved in the development and evaluation of brief CBT interventions for eating disorders and in an effectiveness study of CBT

when delivered in routine clinical settings. It was also declared that HT has a research interest in medical aspects of eating disorders. It was agreed that no action was required.
