- providing an update on sinusitis
- providing an update on acute otitis media

#### 2. GRADE

LP gave a presentation on GRADE.

# 3. Managing common infections – Discussion of evidence and recommendations: sore throat

GF introduced the topic and the evidence found. GF presented symptoms and signs of sore throat. The committee discussed the evidence.

GF presented the evidence on self-care in relation to oral analgesia. The committee discussed the evidence.

GF presented the evidence on self-care in relation to medicated lozenges. The committee discussed the evidence.

GF presented the evidence on self-care in relation to throat sprays. The committee discussed the evidence.

GF presented the evidence on corticosteroids (with antibiotics). AH informed the

committee at this point that he is a co-author of a paper the committee raised (Hayward Gail, Hay Alastair, Moore Michael, Jawad Sena, Williams Nicola, Voysey Merryn, Cook Johanna, Allen Julie, Thompson Matthew, Little Paul, Perera Rafael, Wolstenholme Jane, Harman Kim, Heneghan Carl (2017) Effect of Oral Dexamethasone Without Immediate Antibiotics vs Placebo on Acute Sore Throat in Adults- A Randomized Clinical Trial. CM highlighted to the committee that she is an author in one of the FeverPAIN papers and will therefore leave the meeting for the discussion of recommendations relating to this. The committee discussed the FeverPAIN and Centor scoring systems.

14.15 CM left the meeting. The committee considered recommendation wording.

14.45 CM re-joined the meeting.

GF presented the evidence on complications related to antibiotics. The committee discussed the evidence.

GF presented the evidence on delayed or no prescribing. The committee discussed the evidence and the methods of delaying prescriptions.

The committee discussed and agreed the key messages for the guideline.

#### 4. Update: Acute otitis media

JJ presented an update on acute otitis media. The committee agreed with the process to date. The committee agreed that they are happy to receive future topic updates via email. SH requested that future updates include links to the relevant papers.

#### 5. Possible additional search: prostatitis

RG gave a presentation on a possible additional search on prostatitis. AH and TL stated that prostatitis is difficult to diagnose. He suggested circulating current guidelines to check diagnosis.

#### 6. Update: Sinusitis

RG gave an update on sinusitis. Following discussion the committee agreed to changes to the draft recommendations.

JH outlined the next steps in the development process, advising on the process if committee members are approached about the guideline during consultation.
