#### Yes

Provision of hearing aids is made on the basis of age (over 50) within some clinical Commissioning Groups and the guideline does not comment on this.

The guideline states provision of hearing aids should be based on need and that provision of hearing aids should not be delayed.

The recommendation for followup appointments to be face to face is too restrictive for people who may have difficulty in attending appointments in person because of lack of transport or other support needs given this is primarily and older population.

The committee have revised the recommendation to offer followup appointments by telephone or other remote devices if this is the preference of the person.

The guideline has not addressed access to hearing services and making more provision available locally within the community.

The guideline has cross referred to the patient experience guideline, specifically the tailoring healthcare services section which provides guidance on the principles of applying an individualised approach to meet patient needs.
