6	<p>Health Economic modelling presentation</p> <p>Hazel Pilgrim from ScHARR gave a presentation to inform the discussions on the economic modelling which included:</p> <ul style="list-style-type: none"> • Update and brief overview of the methods employed • Results of the economic evaluation. 	
7,8,9	<p>What can we recommend following the economic modelling and how does it affect our previous ideas for recommendations?</p> <p>The PDG discussed the following:</p> <ul style="list-style-type: none"> • Costs of education for school age mothers and childcare costs • Costs of further education • Prevention of second pregnancies • Impact of mental health issues • Inclusion of state benefit costs <p>ScHARR to undertake a sensitivity analysis.</p> <p>NICE to provide some copies of the DH/DCSF report on 'improving access to sexual health services for young people in further education' at the next meeting. 10,11	<p>Presentation of evidence</p> <p>Kate Guthrie from the Sexual and Reproductive Healthcare Partnership, in Hull and East Yorkshire presented and discussed the factors that make an effective service for socially deprived young people.</p> <p>Questions and discussion</p> <p>Points covered in the discussion included:</p> <ul style="list-style-type: none"> • Active follow-up: • Outreach referrals • Different approaches required for different age groups • Peer mentors • Location of services • Staff training • Record keeping • Child protection issues <p>The NICE team was asked to highlight key issues from this discussion that might be relevant to the development of the guidance</p>	<p>NICE</p>
12,13	<p>Making recommendations in the absence of clear evidence</p> <p>CC reminded the PDG of key issues that need to be taken into account when developing the recommendations. He summarised some of the main challenges, such as weak or only partially applicable evidence and discussed ways of overcoming them.</p>	

14	<p>Economics next steps Hazel Pilgrim and Alastair Forsyth outlined the next steps for the health economic work, based on the earlier discussion. Points raised that may be included in the health economics were:</p> <ul style="list-style-type: none"> • Sensitivity analysis by age and sexual activity • Depression and disadvantage • Further education colleges: see SEF mapping and assess US data • Audit of EHC/unprotected sex • Education and childcare costs • Salary costs • Costs of adverse health outcomes and neonatal care
