2. PRE-CONSULTATION STAGE

2.1 Have any potential equality issues been identified during the development of the quality standard (including those identified during the topic engagement process)? How have they been addressed?

The QSAC advised that the Parent Report of Children's Abilities – Revised (PARCA-R) tool used at the developmental assessment at 2 years (corrected age) might not be suitable if English is not the parent or carer's first language. This issue was also raised for tools used at the assessment at 4 years. Consideration of this issue and the use of alternative suitable questionnaires has been included with the statements on the surveillance up to 2 years and at 4 years.

2.2 Have any changes to the scope of the quality standard been made as a result of topic engagement to highlight potential equality issues?

No changes have been made to the scope of the quality standard at this stage.

2.3 Do the draft quality statements make it more difficult in practice for a specific group to access services compared with other groups? If so, what are the barriers to, or difficulties with, access for the specific group?

The draft statements do not prevent any specific groups from accessing services.

3. POST CONSULTATION STAGE

3.1 Have any additional potential equality issues been raised during the consultation stage, and, if so, how has the committee addressed them?

Stakeholders highlighted that a suitable alternative tool has not been suggested that could be used instead of the Parent Report of Children's Abilities – Revised (PARCA-R) tool at the developmental assessment at 2 years (corrected age) if English is not the parent or carer's first language. The committee discussed alternative options and agreed that clinicians should use their judgement to choose the most suitable alternative assessment for the family. The committee agreed that this wouldn't necessarily be a questionnaire, so the wording for statements 3 and 4 in the quality standard has been changed to reflect this.

3.2 If the quality statements have changed after the consultation stage, are there any that make it more difficult in practice for a specific group to access services compared with other groups? If so, what are the barriers to, or difficulties with, access for the specific group?

No changes have been made after consultation that affect access for different groups.

No potential impact has been identified.
