### REPORT OF DISCUSSIONS AT THE MEETING

### 1 Welcome and apologies

SD welcomed everyone to the 5<sup>th</sup> meeting of the Prostate Cancer GDG.

Apologies for absence were received from Andrew Champion and John Graham, and SD welcomed Judy McBride (and editor from NICE).

### 2 Declarations of interest

SD noted that the following GDG members have declared the following interests since the last GDG meeting:

- HK has made a number of declarations which the NCC-C are still categorising with NICE. Until this is complete HK should withdraw from discussions on topic 10 today.
- The declaration regarding Varian made at the 2<sup>nd</sup> GDG meeting by PH has been categorised with the NCC-C and NICE as non-personal, pecuniary specific and therefore PH should withdraw from discussions on topic 8. A new lead contact will be agreed under agenda item 3. He can answer questions from the GDG about the evidence review.
